



2022 Maryland Candidate Survey State Legislative District 21

The Maryland Council for American Private Education (CAPE) advocates for the interests of the 125,000-plus nonpublic students in Maryland and their families. We invited all gubernatorial and General Assembly candidates to respond to a brief candidate survey (“support” or “oppose”), and provide a brief comment on each answer, on critical issues for non-public schools in Maryland. 2022 Candidate Questions | State district and gubernatorial responses follow

1. Aid to Nonpublic Schools

Generally speaking, do you support or oppose state dollars going to nonprofit nonpublic schools to support educating the children who attend?

2. “Public Dollars”

Do you support or oppose the statement “Public dollars are only for public schools”?

3. Education Opportunity Scholarships

Do you support or oppose the statement “Parents should have the right to utilize the state dollars allocated for their child’s education at whatever school they choose for them, whether public, private or charter”?

4. BOOST Scholarship Program

Do you support or oppose funding for Maryland’s existing BOOST Scholarship Program, which provides scholarships to low-income students to be used to attend nonpublic schools, at its current levels for new students?

5. Capital Dollars for Private Schools

Do you support or oppose state support for infrastructure or security upgrades and maintenance being allocated to nonpublic schools in the state budget?

Open-ended Candidate Answers

District 21 State Senator Candidates

Jim Rosapepe (D)

Q1: Aid to nonpublic schools: Depends on specifics and amounts and not at expense of public schools

Q2: Public dollars: Maryland and the federal government provide a variety of support for students in private pre-k, k-12, and higher ed

Q3: Educational scholarships: It's complicated and depends on the specifics.

Q5: Capital dollars: Depends on specifics and amounts

Lee Havis (D)

Q1: Tax revenue, which is then allocated to fund so-called "public schools"? I support parent choice of education of their children. Better "funding" of education is by tax exemption and lower taxes for educational purposes, for example, based on number of dependent children within a certain age range. With an end to compulsory schooling, there would be even less incentive for state taxation to support those schools that function under government legislative and regulatory control.

Q2: If that term were defined to include non-government alternatives, the use of "public dollars" would be more wisely spent. However, control and regulation of such alternatives must not be used for purposes of censorship and monopoly control, such as may occur through business cartels and non-government special interest groups.

Q3: The general concept of allocating so-called "state dollars" is better directed to parents for their own choice of education. However, regulation and control is always an issue and obstacle where government funds are involved. The better approach is to end all government funding in "public education", except for those in the category of low-income poverty. Parents, in general, make wiser choices for education of their children when they are spending their own money for that purpose. Reducing taxes, by raising the "dependent" allowance is wiser approach than taxing first, and then allocating funds through the inefficient, wasteful system of government management.

Q4: Not familiar with this program. Any time government funds anything, the question of control, censorship, and monopoly emerges as an issue to stifle free marketplace choice in any field. However, private non-government scholarship funding is certainly a useful and valuable way to advance many types of progress and benefit in society.

Q5: Government funds directly to private institutions is a danger and moral risk of misuse of such funds. Private funding of private institutions is a wiser means to support the benefit of competition and choice, especially in the field of education.

Gubernatorial Candidates

Dan Cox (R)

Q1: Nonpublic school aid: I support the dollars following the children by parental choice.

Q4: BOOST: And I would expand this program.
